AUCTION NOTICE GALERIE KODL, S.R.O.

In the context of this Auction Notice, the Auction House shall mean Galerie Kodl, s.r.o., which organises the auction of artworks. This auction shall be held on 30 November 2025 from 12 p.m. at Žofin Pa lace on Slovanský Ostrov in Prague 1. The live auction shall be preceded by the limitation stage, which shall take place from 3. 11. 2025 till 29. 11. 2025, at www.galeriekodl.cz and at www.artslimit.com

I. Bidders Club

- The Auction House shall perform the auction at request of owners of the items offered for sale at the auction. The auction, including the limitation stage, is not open to the general public, it is accessible to members of the Bidders Club of Galerie KODL only. This club can be joined
- it is accessible to members of the Bidders Club of Galerie KODL only. This club can be joined by any interested party anytime, even on the date of the auction, too, on condition that the interested party meets the membership requirements stipulated herein.

 The Bidders Club can be joined by anyone who proves that they are older than 18 years and have full legal capacity to act on their behalf. If the interested party is a legal entity, then it is required that it has its registered office on the territory of the Czech Republic and that it has a legal representative to act on its behalf at the auction. At the registration, the Auction House has then the right to demand presentation of their identity card or passport, in case of legal entity it is needed to present the up-to-date extract from the Commercial Register. It is the Auction House who ultimately decides about the registration for the Bidders Club, there is no right to the membership. Should a member of the Club break the rules set in this Notice, the Auction House has the right to cancel their membership and is obliged to inform them about this decision.

- II. Limitation Stage
 If a member of the Bidders Club of Galerie KODL wants to join the auction already at the limitation stage, then such member shall get registered on www.galeriekodl.cz or on www.artslimit.com and proceed in compliance with Act No. 253/2008 Coll., on Certain Measures Against the Legalization of Proceeds of Crime and Terrorist Financing (hereinafter referred to as "AML Act"). It should be noted that the Auction House has the right, without giving a cause, to deny participation of an interested party in the limitation stage (there is a legal right neither to the registration for the limitation stage, nor to the participation in the limitation stage).

 At the limitation stage, it is possible, on the web, to set a personal maximum bid for an offered item. Once the limitation stage is over, and the live auction follows up, the bidding starts for each of the offered items either at the starting price or at the last bid amount, namely at the amount of the highest bid from the web. III. Registration Conditions
